Housing: Assessment complete; No specific actions done on 2-3; 4 and 5 partially addressed by new Extended Village District; 6 and 9 supported by The Bend Revitalization Committee and may be supported by Rural Edge; 7 and and 8 supported by the Housing Committee. Facilities: 1 is a priority for the PC action; Brett Stanciu relays that Kristen Leahy suggests mixed use. 2 completed; 3 Is it a PC responsibility? Kent Hansen will explore with Dan Predpall. Economic Opportunities: 1 and 3 are aspirational; 2 is being supported by Wastewater Committee; 4 is not possible given workload of SB; 5 supported by The Bend Revitalization



Committee.

Kent Hansen will produce a spreadsheet of action items in the Town Plan for the PC to use in prioritizing the PC's work for the next year.

Meghan Wayland inquired about leveraging Land Trust Properties for affordable housing. Ellen Celnick pointed out that the PC cannot develop property and that such an initiative would need to come from the Land Trust or a private developer.
